This Website Privacy Policy describes how we may collect, use, disclose, and protect information obtained through our website and online services.

Information We May Collect

PPG may collect information that you voluntarily provide to us, including:

- Name
- Email address
- Phone number

We may also automatically collect certain technical information when you visit our website, including:

How We Use Information

PPG may use collected information for purposes including:

- Recruiting and hiring activities
- Provider onboarding and credentialing
- Operational and administrative communications
- Scheduling and coordination activities
- Improving website functionality and user experience
- Analytics and performance monitoring
- Compliance, legal, and security purposes

Text Messages and Electronic Communications

Once an applicant applies through one of PPG’s job boards, recruiting platforms, or online application systems, PPG may review the application and contact the applicant regarding potential next steps in the hiring or onboarding process.

Applicants may be contacted through phone calls, emails, and text messages (SMS) regarding:

Additionally, PPG's employment applications and recruiting forms may include disclosures advising applicants that by submitting an application, they consent to receive communications related to recruiting, onboarding, credentialing, scheduling, operational updates, and other employment-related matters.

Message and data rates may apply. Message frequency may vary.

You may opt out of text messaging communications at any time by replying STOP where applicable or by contacting PPG directly.

PPG does not sell personal information or use text messaging for third-party marketing purposes.

Cookies and Analytics

Our website may use cookies, analytics tools, and similar technologies to improve website performance, understand visitor interactions, and enhance user experience.

You may modify your browser settings to decline cookies; however, certain website functionality may be limited.

Sharing of Information

PPG may share information with authorized workforce members, contractors, vendors, service providers, and business associates who assist with operational, recruiting, onboarding, credentialing, technology, analytics, communication, and administrative services.

PPG does not sell personal information to third parties.

We may also disclose information:
